2. Hazards Identification

Not dangerous with normal use. Do not dismantle, open or shred battery. Exposure to the ingredients contained within or their ingredients products could be harmful.

Primary routes of exposure: These chemicals are contained in a sealed can. Risk of exposure occurs only if the battery is mechanically, thermally or electrically abused. If this occurs, exposure to the electrolyte solution contained within can occur by Inhalation, Ingestion, eye contact and skin contact.

Potential Health Effects:

Inhalation: Inhalation of materials from a sealed battery is not an expected route of exposure. Vapors or mists from a ruptured battery may cause respiratory irritation.

Swallow: Swallowing of materials from a sealed battery is not an expected route of exposure. Swallowing the contents of an open battery can cause serious chemical burns of mouth, esophagus, and gastrointestinal tract.

Skin: Contact between the battery and skin will not cause any harm. Skin contact with contents of an open battery can cause severe irritation or burns to the skin.

Eye: Contact between the battery and the eye will not cause any harm. Eye contact with contents of an open battery can cause severe irritation or burns to the eye.

6.Accidental Release Measures

Steps to be taken in case material is released or spilled

If the battery material is released, remove personnel from area until fumes dissipate. Provide

maximum ventilation to clear out hazardous gases. Sweep up using a method that does not

generate dust. Collect as much of the spilled material as possible, place the spilled

material into a suitable disposal container. The preferred response is to leave the area and

allow the batteries to cool and vapors to dissipate. Avoid skin and eye contact or inhalation of

vapors.

Waste Disposal Method

It is recommended to discharge the battery to the end, handing in the abandoned batteries to

related department unified, dispose of the batteries in accordance with approved local, state,

and federal requirements. Consult state environmental protection agency and/or federal EPA.

7. Handling and Storage

The batteries should not be opened, destroyed or incinerate, since they may leak or rupture

and release to the environment the ingredients that they contain in the hermetically sealed

container. Do not short circuit terminals, or over charge the battery, forced over-discharge,

throw to fire. Do not crush or puncture the battery, or immerse in liquids.

Precautions to be taken in handling and storing

Avoid mechanical or electrical abuse. Storage preferably in cool, dry and ventilated area, which

is subject to little temperature change. Storage at high temperatures should be avoided. Do

not place the battery near heating equipment, nor expose to direct sunlight for long periods.

Engineering Controls

11.Toxicological Information

be done in authorized facility, through licensed waste carrier.
